APPEAL FOR FINANCIAL SUPPORT IN ACQUISITION OF CHURCH PROPERTY

Shalom!

Dear Members and Worshipers of LSMC/ Friends of LSMC and Brothers & Sisters in Christ,

LSMC has since 17 September, 2017 launched a church acquisition fund raising for the acquisition of its own church premises.

Properties in and around Kota Damansara where LSMC is situated are being considered to house the church. Work has been carried out by our Property Acquisition Committee to identify a suitable and affordable property.

Based on the current market conditions, it is anticipated that the premise acquisition price could be in the region of RM3,000,000.


As a prerequisite of the Trinity Annual Conference (TRAC) Guidelines on property purchase, we need to meet at least 70% of the fund requirement while the remaining 30% may be raised among TRAC churches by way of donations or interest free loans. We therefore need to raise 70% (i.e. RM2,100,000) of the targetted acquisition costs on or before 30 June 2018 in order for it to be considered as a Trinity Annual Conference Project for the year 2019.

To date, we have been able to collect about 40% of the 70% of the required costs of acquisition internally from members and regular worshipers whilst more will contribute.


In view of this, we appeal to members, regular worshipers and friends of LSMC as well as brothers and sisters in Christ to prayerfully help us by supporting us in this project with a contribution.

We increasingly commit our prayers to God our Father that our vision and mission will succeed for the Glory of His Kingdom!
